

ARTICLES OF INCORPORATION OF

(A Florida Corporation Not for Profit)

The undersigned, acting as Incorporator of a corporation, adopts the following Articles of Incorporation for such corporation.

ARTICLE I

CORPORATE NAME

The name of the Corporation shall be _

SAINT'S SANCTUARY.

ARTICLE II

DURATION

The period of duration of this Corporation is perpetual, unless dissolved according to law. Corporate existence shall commence upon the filing of these Articles of Incorporation.

ARTICLE III

CORPORATE PURPOSES: POWERS

1. The purposes for which the Corporation is organized and operated are exclusively spiritual, charitable, scientific, literary and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future united states internal revenue law. Such purposes shall include the following:

(a) Spiritual

- (b) To conduct a local church by the direction of the Lord Jesus Christ and under the leadership of the Holy Ghost in accordance with all of the Commandments and provisions as set forth in the Holy Bible, the irrevocable Word of God. Pursuant thereto the following activities and guidelines shall be established.
 - i. A recognized Creed, Code of Doctrine, discipline and form of worship, shall be established.
 - ii. An ecclesiastical form of government shall be established.
 - iii. Ordination of ministers upon completion of the prescribed course of study designated by this Church Ministry.

- iv. An organization of ministers shall be established to minister to the concongregation of the Church.
- v. Establishment of a Church membership based upon acceptance of a rerecognized creed and belief and support of the Church.
- vi. Spread the Word of the Gospel through seminars, radio, television, establishmentof Church literature, and other forms of mass media for the purpose of education the individual in the Word of God.
- vii. Establishment of various spiritual services pursuant to the recognized Creed, form of worship, code of doctrine and discipline of the Church and the establishment of Schools for spiritual and educational instruction to the young and to the old.
- viii. Establishing a school for the preparation of ministers who minister to the Church.
 - (c) Minister the Word of God to the faithful.
- (d) Promote and encourage, through the ministry of the organization, cooperation with other organizations, ministering within the community.
- (e) To acquire and hold such property, either real or personal, for Church purposes, as be necessary for its membership and the worship of God.
- 2. As a means of accomplishing the above purposes and methods, the Corporation shall have the following powers:
- (a) To receive and accept gifts of money and property and to hold the same for any of the purposes of the corporation and its work.
- (b) To raise and assist in raising funds for the purposes herein set forth, including the issuance of bonds or other instruments of credit.
- (c) To acquire, own, lease, mortgage and dispose of property, both real and personal.
- (d) to conduct and carry on spiritual services and instruction through the public media including electronic broadcasting, AM and FM radio, telecasting, microwave distribution, closed circuit transmission, and cable television.
 - (e) To accept property and donations in trust for spiritual or charitable purposes.
 - (f) To acquire, hold, own, sell, assign, transfer, mortgage, pledge, or otherwise disposepose of shares of the capital stock, bonds, obligations or other securities of other corporations, domestic, or foreign, as investments or otherwise, in carrying out any of the purposes of the Corporation and, while the owner thereof, to exercise all rights, powers and privileges of ownership, including the power to vote there-
 - 3. In the conduct of the affairs of the Corporation:

- (a) The property of the Corporation is irrevocably dedicated to spiritual, educational and charitable purposes, and no part of the net earnings of the Corporation shall inure to the benefit of or be distributed to its members, directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered to it and to make payments and distributions in furtherance of the purposes set forth in this article.
- (b) No substantial part of the activities of the Corporation shall exist of carrying on propaganda, or otherwise attempting to influence legislation: nor shall it in any manner or to any extent participate in, or intervene in (including the publishing or distributing statements) any political campaign on behalf of any candidate for public office; nor shall the Corporation engage in any activities that are unlawful under applicable federal, state, or local laws.
 - (c) The Corporation shall not:
 - (1) operate for the purpose of carrying on a trade or business for profit;
 - (2) accumulate income, invest income, or divert income, in a manner endangeringits exempt status; or
 - (3) except to an insubstantial degree, engage in any activity or exercise any powers that are not in furtherance of the purposes of the Corporation.
- (d) The Corporation's operations are to be conducted principally in the United States of America; the Corporation also may conduct or erations in foreign countries, subject, however, to the laws of the State of Florida.

ARTICLE IV

REGISTERED OFFICE AND AGENT

The initial street address and among address principal office and registered office of the Corporation is: 4119 N DIXIE HIGHWAY, POMPANO BEACH, FL 33064, and the name of the registered agent at such address is BISHOP KEITH JENKINS.

ARTICLE V

MANAGEMENT OF CORPORATE AFFAIRS

The powers of the Corporation shall be exercised by or under the authority of, and the business and affairs of the Corporation shall be managed under the direction of a Board of directors which shall have three (3) directors initially. The number of directors may be increased from time to time by a majority of the directors, but at no time shall there be fewer than three (3) directors of the Corporation.

ARTICLE VI

INITIAL DIRECTORS

The manner in which the Directors of the Corporation shall be elected or appointed shall be governed by the provisions of the Bylaws of the Corporation. The names and street addresses of the initial directors of the Corporation are:

CORPORATE NATURE

This Corporation is organized under a non - stock basis.

ARTICLE VIII

MEMBERS

This Corporation shall have members and they shall be admitted and qualified in accordance with the Bylaws adopted by the Board of Directors.

ARTICLE IX

AMENDMENTS

Amendments to these Articles of Incorporation may be adopted by a majority of the directors in the manner set forth in the Bylaws of this Corporation.

(a) Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on:

(1) by a corporation exempt from federal income tax under Section

(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States internal revenue law) or,

- (2) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or the Corresponding provision of any future United States internal revenue law).
- (b) In the event of the dissolution of this Corporation, or in the event it shall cease to carry out the objectives and purposes herein set forth, all of the business, property and assets of the Corporation shall go and be distributed to ZION HILL CHRISTIAN CENTER, INC. qualifying as an organization exempt under the provisions of Section 501 (c)(3) of the Internal revenue Code of 1986, as amended, or any superseding statute thereof, and as an organization qualifying as a Not for Profit Corporation in the State of Florida. In no event shall any of said assets or property, in the event of dissolution thereof, go or be distributed or contributed by such trustees, for any other such purpose. Any of such assets not so disposed of shall be disposed of by the District Court of the County in which the principal office of the Corporation is then located, exclusively for such purposes, or to such organization or organizations as said court shall

determine, which are organized and operated exclusively for such purposes.
