ARTICLES OF AMENDEMNT
TO THE ARTICLES OF INCORPORATION
OF
GOD'S ARMY, INC.

The Undersigned Corporation adopts the following Articles of Amendment to its Charter of Incorporation.

First: Article

This corporation is created to bring relief to those who are hurting in accordance with the commands of Jesus Christ. The purpose of the corporation is charitable and religious within the meaning of Section 501 (c) (3) of the Internal Revenue Code.

This corporations shall have the power to buy, sell, own, mortgage, rent, lease, or otherwise acquire and dispose of real and personal property necessary and proper for its stated purpose and to do any and all lawful acts and things and to engage in any and all lawful activities which may be necessary useful, suitable, desirable, or proper for the furtherance, accomplishment, fostering, or attainment of the purpose for a which the corporation is created.

In the event of liquidation or dissolution of the corporation, no member or officer shall be entitled to any distribution or division of its remaining property or its proceeds, and a the residual assets of the corporation, after the payment of all debts and obligations of the corporation, shall be turned over to one or more organizations which themselves are exempt from Federal Income Tax under 501(c) (3) of the Internal Revenue code of 1954 or the corresponding provision of any future United States Internal Revenue Law.

Second: The amendment of the Charter of Incorporation was adopted by the members of the corporation on November 12, 1997 at a special meeting of the members of the corporation at Crystal River, Florida.
