The undersigned, Mark S. Steinberg, for the purpose of forming a corporation not for profit, in accordance with Florida Statutes, Chapter 617, does hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of this corporation shall be The Florida Motion Picture and Television Association Miami/South Florida Chapter, Inc..

ARTICLE II CORPORATE OFFICES

The principal office from which business activity will be held shall be 9348 Collins Avenue #25 Surfside, Florida 33304. The principal office from which mai! may be received shall be 9737 Northwest 41st Street Suite 118 Miami, Florida 33778.

ARTICLE III CORPORATE DURATION

The existence of this corporation shall commence on the 1st Day of December, 1995, provided that if such day be unauthorized under law, then on the earliest day allowable pursuant to Florida Law for the commencement of corporate existence. The corporation shall continue perpetually unless dissolved according to law.

ARTICLE IV CORPORATE PURPOSE OR PURPOSES

The purpose for which the corporation is organized are as follows:

- (a) To promote the film, television, and recording industries in the State of Florida;
- (b) To promote and support increased opportunities for the development of film, television, and recording productions by Floridians and Florida based production companies;

ARTICLE VI INITIAL BOARD OF DIRECTORS AND OFFICERS
