The undersigned, acting as incorporator of a Corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

## ARTICLE I: NAME

## ARTICLE III: PURPOSES

THE PURPOSES FOR WHICH THE CORPORATION IS ORGANIZED ARE:



