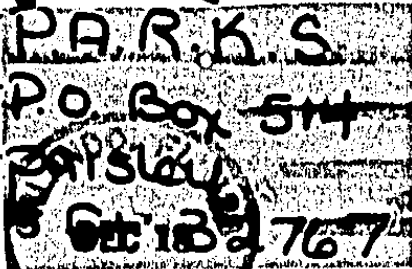

ARTICLES OF INCORPORATION OF

Paisley Association for Recreational Kids, Inc.

A FLORIDA NOT FOR PROFIT CORPORATION

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617 of the Florida Statutes, adopt the following Articles of Incorporation for the corporation:

Article I
Name

The name of the corporation shall be
Paisley Association for Recreational Kids, Inc.
The principal address of the corporation at the time of
incorporation is Post Office Box 514, Paisley, Florida 32767
County of Lake.

Article II
Duration

The duration of this corporation is perpetual, unless
dissolved according to law.

Corporate existence shall commence on the date these
articles of incorporation are filed by the Department of
State.

Article III
Purpose

(a) The specific and primary purposes for which this corporation is organized are to acquire and maintain buildings and property for a community center, including club rooms, reading rooms and educational and recreational facilities to serve the community of Paisley, Florida, and to acquire other properties, and to construct buildings for the above purposes; to engage in all types of activities not prohibited by law that will promote better citizenship among its members, and to stimulate educational, recreational, physical and social activities among its members and friends so they may acquire an understanding of other cultures and languages; to promote and foster mutual understanding and good will among persons of all ancestry; to engage in activities that will raise the standards of civic morality and community welfare through educational, recreational and social means; and to disseminate knowledge which may be useful for its members in their work and home life and, as a result, to make them more proficient in their activities as citizens and residents of Florida.

(b) The general purposes for which this corporation is organized are: to erect, construct, purchase, repair, improve, maintain, and operate recreational, sports, and game facilities, buildings, and areas of every kind, including tennis courts and swimming pools, for the benefit of its members, and to promote social intercourse among them.

(c) This corporation is formed and shall be operated exclusively for pleasure, recreation, and other nonprofit purposes. No part of any net earnings shall inure to the benefit of any member, trustee, or officer of the corporation except as provided by law.

(d) This corporation shall have and exercise all powers conferred upon not for profit corporations under the laws of the State of Florida generally and specifically as provided in Section 617.0302 of the Florida Not for Profit Corporation Act, provided, however, that this corporation has no power to engage in any activity that in itself is not in furtherance of its purposes as set forth in paragraphs (a) through (c) of this Article III.

Article IV Qualifications and Admission of Members

The authorized number, qualifications, and manner of admission of members of this corporation, the property, voting, and other rights and privileges of members, the liability of members for dues and/or assessments and the method of collection, and the termination and transfer of membership shall be as set forth in the bylaws of this corporation.

Article V Registered Office and Registered Agent

The street address of the corporation's initial registered office is 43809 Sunset Drive, Paisley, County of Lake, Florida, and the name of the corporation's initial registered agent at that address is Joe W. Shipes.

Article VI
First Board of Directors

The following persons shall serve the corporation as directors until the first annual meeting or other meeting called to elect directors:

ARTICLE VII
Basis Under Which Corporation Organized

The corporation is a not for profit corporation as defined by the Not for Profit Corporation Act in Section 617.01401 of the Florida Statutes, As such, it is not organized for the pecuniary gain or profit of, and its net earnings nor any part thereof is distributable to, its members, directors, managers, officers, or other private persons except as specifically permitted under the provisions of the Florida Not for Profit Corporation Act.

ARTICLE VIII
Management of Corporate Affairs

(a) Board of Directors. The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a board of eight (8) directors. The number of directors provided for in these Articles of Incorporation may be changed by a bylaw adopted by the board of directors, but never shall be less than three (3) directors.

(b) Election of Directors. The method of electing directors shall be as set forth in the bylaws.

(c) Elective Officers. The officers of this corporation shall be a president, a vice-president, a secretary, and a treasurer. Other offices and officers may be established or appointed by the members of this corporation at any regular annual meeting or any special meeting of members called for such purpose. The qualifications, the time and manner of electing or appointing, the duties of, the terms of office, and the manner of removing officers shall be set forth in the bylaws.

(d) Standing Committees. The standing committees shall be determined by the bylaws. The powers and duties of these committees shall be as specified in the bylaws. Other committees, and their powers and duties, may be specified in the bylaws or may be appointed by the Board of Directors.

ARTICLE X Bylaws

Bylaws will be adopted at the first meeting of the board of directors. The bylaws may be amended, repealed, in whole or in part, by the members in the manner provided in the bylaws. Any amendments to the bylaws shall be binding on all members of this corporation.

ARTICLE XI Amendment of Articles

Amendments to these articles of incorporation may be proposed by a resolution adopted by the board of directors and presented to a quorum of the voting members for their vote. Amendments may be adopted by a vote of two-thirds (2/3) of a quorum of the voting members of the corporation.
