
Dear Ms. Chesser:

ARTICLE ONE

The name of the Corporation is **FLORIDA DRAFTHORSE PULL ASSOCIATION, INC.**

ARTICLE TWO

Principal Office and Address

The address of the principal office of the corporation is 7083 N. Lecanto, Hernando, Florida, and the mailing address of the corporation is the same.

ARTICLE THREE

Duration

The term of existence of the Corporation is perpetual and the corporate existence will commence on the filing of these articles by the Department of State.
