

ARTICLES OF INCORPORATION of

CHILDREN'S RIGHTS INTERNATIONAL ORGANIZATION INC.

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be:

CHILDREN'S RIGHTS INTERNATIONAL ORGANIZATION INC.

ARTICLE II PRINCIPLE OFFICE

The principal office and mailing address shall be:

4716 S.W. 75 Ave, Miami FI 33155

ARTICLE III TERM

This corporation shall exist perpetually.

ARTICLE IV PURPOSE

This corporation is formed for such purposes as will qualify it as an exempt organization under section 501(c) 3 of the Internal Revenue Code of 1986. Within the scope of the forgoing, the object of this corporation is Charitable within the meaning of Section 5(c)(3) of the Internal Revenue code of 1986 of the corresponding provisions of any future United States Revenue law.

The purpose for which this corporation is organized is to proclaim the rights of the citizens of minor age, to create a conscience of respect and equality that will ensure a just opportunity for the men and women of tomorrow to life, wellbeing and a harmonious development. To disseminate information on the specific topic of child abuse and neglect, as a first hand solution and to create centers of development that will support the needs of those who have been victimized by the the unbalance of our present society.

This corporation is organized and operated for purposes that are beneficial to the public interest such as the defense of human and civil rights secured by law to all man without distinction of race, age, sex or creed. And to combat family and social deterioration directing all efforts to the protection of the Child as its basis and to ensure him the opportunity of fullfilling his mission in society both as a Child and as the future of humanity by preventing the abuse, neglect and the cruelty inflicted on him due to discrimination of his age.

ARTICLE V

This corporation shall issue no stock. No part of the net earnings of this corporation shall insure to the benefit of or be distributeble to its members, director officers or other private person exept that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered. No Member director or officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets upon dissolution of the corporation.

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.
