SECOND: Adoption of dissolution:

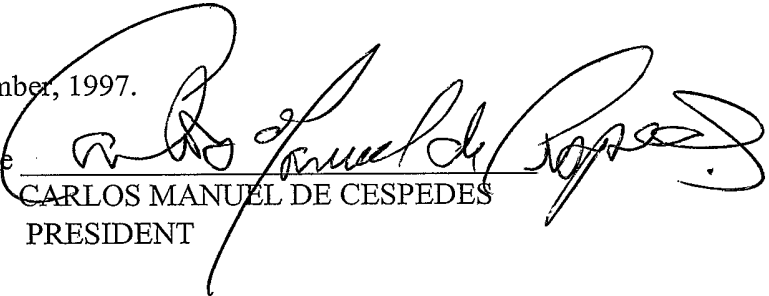
The corporation has no members or members with voting rights.
