

ARTICLES OF INCORPORATION

OF

MEADE MINISTRIES, INC. A Florida Not For Profit Corporation

•

The undersigned persons, acting as incorporators of a corporation not for profit under the Florida Not For Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, hereby adopt the following Articles of Incorporation for the corporation:

ARTICLE_I

The name of the corporation shall be: MEADE MINISTRIES, INC.


ARTICLE_II

The corporation shall have perpetual existence.

ARTICLE III

The corporation is a not for profit corporation. The specific and primary purposes for which this corporation is formed are to operate for the advancement of the ministry of the gospel of Jesus Christ and for other charitable purposes, by the use of its resources and distribution of its funds for such purposes, and particularly:

A. To make and perform contracts of any kind and description; and for the purpose of attaining any of the objectives of the corporation; to do and perform any other act or thing; and



to exercise any and all powers which a co-partnership or a natural person could do and exercise and which are now or hereafter may be authorized by law, and generally to do and perform any and all things necessary or incident to the performing and carrying out of the powers hereinabove specifically delegated or implied.

- B. To operate exclusively for such ecclesiastical, charitable and educational purposes as will qualify it as an exempt organization under Section 501 (c) (3) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making of distributions to organizations which qualify as tax-exempt organizations under that Code.
- C. To be organized as a church, the members of which are dedicated to the promise and covenant to live together in unity and to work together in ministry as disciples of Jesus Christ, bound to Him and to one another as a part of the body of Christ.
- D. This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

ARTICLE_IV

The corporation shall have a membership as established by the board of directors in the bylaws. The authorized number and

qualifications of the members of the corporation, the manner of their admission, the different classes of membership, if any, the property, voting, and other rights and privileges of members shall be as regulated in the bylaws.

ARTICLE_Y

The street address of the initial principal office of the corporation is Glenwood Circle, Southwood Acres, Lake City, Florida 32024, which mailing address is Post Office Box 2307, Lake City, Florida 32056-2307. The name of the registered agent at that street and mailing address is Marlene H. Meade. The principal office address of the corporation and the address of the registered agent are the same.

ARTICLE VI

The powers of this corporation shall be exercised, its property controlled, and its affairs conducted by a board of directors. The number of the directors shall be not less than three (3) nor more than nine (9) persons; provided, however, that number may be changed by bylaws duly adopted pursuant to the bylaws of this corporation.

The directors named here as the first board of directors shall hold office until the first meeting of members to be held on January 20, 1996, at 2:00 P.M. at Glenwood Circle, Southwood Acres, Lake City, Florida 32024, at which time an election of directors shall be held.

Directors elected at the first annual meeting and at all subsequent times shall serve for a term of one (1) year until the next annual meeting of members following the election of directors and until the qualification of the successors in office. Annual meetings shall be held at 2:00 P.M. on the first Monday in January of each year at the principal office of the corporation or at any other place or places and dates and times as may be designated by the board of directors by resolution.

Any action required or permitted to be taken by the board of directors under any provision of law may be taken without a meeting, if all the members of the board individually or collectively consent in writing to the action. Written consent or consents shall be filed with the minutes of the proceedings of the board, and any action by written consent shall have the same force and effect as if taken by unanimous vote of the directors. Any certificate or other document filed under any provision of law that relates to action taken in this manner shall state that the action was taken by unanimous written consent of the board of directors without a meeting and that the articles of incorporation and bylaws of this corporation authorize the directors to act in this manner. This statement shall be prima facie evidence of the directors' authority.

ARTICLE_VIII

The board of cirectors shall elect the following officers: President, Vice-President, Treasurer, and Secretary, and any other officers which the bylaws of this corporation may authorize the directors to elect. Initially, officers shall be elected at the first annual meeting of the board of directors. Until that election is held, the following persons shall serve as corporate officers: President, Charles Meade. Post Office Box 2307, Lake City, Florida 32056-2307; Vice-President/Secretary-Treasurer, Marlene H. Meade, Post Office Box 2307, Lake City, Florida 32056-2307.

ARTICLE IX

Subject to the limitations contained in the bylaws and any limitations set forth in the Not For Profit Corporation Act of Florida described above, concerning corporate action that must be authorized or approved by the members of the corporation, the bylaws of this corporation may be made, altered, rescinded, added to, or new bylaws may be adopted, either by a resolution of the board of directors or by following the procedure set forth in the bylaws.

ARTICLE_X

The property of this corporation is irrevocably dedicated to religious purposes as set forth in Article III, and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member, or to the benefit of any private individual.

ARTICLE XI

On the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a not for profit fund, foundation, or corporation which is organized and operated exclusively for religious purposes as set forth in Article III and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.

ARTICLE III

Amendments to these articles of incorporation may be proposed by a resolution adopted by the board of directors and presented to a quorum of members for their vote. Amendments may be adopted by a vote of at least two-thirds of a quorum of members of the corporation.
