ARTICLE I. NAME

The name of the Corporation is: MANASOTA WORKFORCE INVESTMENT BOARD, INC.

ARTICLE II. DURATION

The duration of the Corporation is perpetual.

ARTICLE III. PURPOSES AND POWERS

- B. The purposes for which MANASOTA WORKFORCE INVESTMENT BOARD, INC., is organized are exclusively charitable within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- C. 


