The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

Name

ARTICLE II

Principal place of business and mailing address

ARTICLE III

Purpose(s)

The specific purpose(s) for which the corporation is organized is(are):

To be a local church of the United Church of Christ in Tallahassee, Florida, as a place of worship for and religious education of its members.

ARTICLE IV

Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

The directors shall be elected by the congregation (members) at a duly called annual meeting of the congregation for terms of two (2) years except for the positions of Treasurer and Financial Secretary who are elected for open-ended terms. A director may be re-elected for one successive two-year term.

ARTICLE V

Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617 0302, Florida Statutes, unless limited are as follows

The congregation, at a duly called meeting of the congregation, retains the power to adopt and amend the Constitution and By-Laws of the corporation, to approve the calling and/or release of the Pastor(s), to approve annual budgets for the corporation, and to request the directors to act on its behalf in legal and financial matters affecting the corporation.
