ARTICLES OF INCORPORATION

OF
Migration and Diaspora Research Institute, Inc.
A FLORIDA NONPROFIT CORPORATION

Article 1. Name. The name of the Corporation is: **MIGRATION AND DIASPORA RESEARCH INSTITUTE, Inc.**

Article 2. Duration. The duration of the Corporation is perpetual.

Article 3. Purposes. The purpose of the corporation is as follows

A. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. This not organized for the private gain of any person. the specific purposes of this corporation is to conduct academic research.

B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

C. Provided, however, that the corporation shall not engage in any acting which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes

Article 4. Members. The Corporation shall have Non-Voting Members, who shall be elected (and may be removed) by the Board of Directors.
