BY THESE ARTICLES OF INCORPORATION the incorporators form a corporation under Florida law.

1. **NAME.** The name of the corporation is **RON WALKER MINISTRIES, INC.**
2. **TERM.** This corporation shall exist perpetually.
3. **PURPOSES.** (a) The purpose for which this corporation is organized is to create a platform for evangelism and the promotion of revivals in the U.S. and other countries.

(b) This corporation shall issue no stock. No part of the net earnings of this corporation shall inure to the benefit of or be distributable to its members, directors, officers or other private persons except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this article. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation. This corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office, including the publishing or distribution of statements. Notwithstanding any other provision of these

articles, this corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under § 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States internal revenue law, or by a corporation, contributions to which are deductible under § 170(c)(2) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States internal revenue law. On the dissolution of this corporation the board of directors shall dispose of all of the assets of this corporation exclusively for the purposes of this corporation in the manner or to the organization exclusively for the purposes of this corporation in the manner or to the organization or organizations that are organized and operated exclusively for charitable, educational, religious or scientific purposes and that shall at the time qualify as exempt organizations under § 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States internal revenue law, after paying or making provisions for the payment of all liabilities of this corporation. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county where the principal office of this corporation is then located exclusively for the purposes or to the organizations that the court determines are organized and operated exclusively for charitable, educational, religious or scientific purposes.

4. **MEMBERS.** The qualifications for and manner of admission of members shall be regulated by the bylaws. **The manner in which the directors are elected or appointed is by the bylaws.**

5. **REGISTERED OFFICE.** The street address of the corporation's principal office and initial registered office of the corporation in the State of Florida is Suite 408, Center Pointe, 2033 Main Street, Sarasota, Florida 34237. The Board of Directors may from time to time move the principal office to any other address in Florida. The corporation may maintain offices and transact business in such other places within or without the State of Florida as may be designated by the Board of Directors.

6. **DIRECTORS.** The corporation shall have three directors initially. The number of directors may be changed from time to time in the bylaws. The name and address of each person who is to serve as an initial director is:

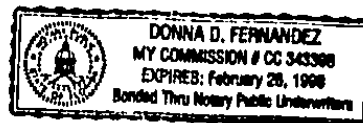
