ARTICLES OF INCORPORATION

BY THESE ARTICLES OF INCORPORATION the incorporators form a corporation under Florida law.

- 1. NAME. The name of the corporation is RON WALKER MINISTRIES. INC.
 - 2. TERM. This corporation shall exist perpetually.
- 3. PURPOSES. (a) The purpose for which this corporation is organized is to create a platform for evangelism and the promotion of revivals in the U.S. and other countries.
