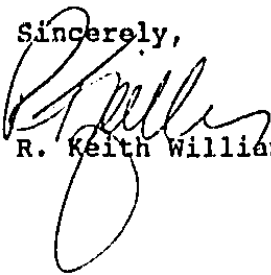

The undersigned, being a natural person, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a not for profit business corporation pursuant to the provisions of the Florida Not-for-Profit Corporation Act.

ARTICLE I

FAITH FELLOWSHIP CHURCH OF BREVARD, INC.

The name of this Corporation (hereinafter "CORPORATION") shall be:
FAITH FELLOWSHIP CHURCH OF BREVARD, INC.

ARTICLE II

PURPOSE OF BUSINESS

The purpose of this CORPORATION is to engage in any lawful business for which not-for-profit corporations may be incorporated under the Florida Not-for-Profit Corporation Act. This church, as part of the Body of Christ, has formed this corporation for the purpose of furthering christian ministry and spreading the gospel of Jesus Christ our Lord and Savior.

ARTICLE III

TERM OF EXISTENCE

The existence of this Corporation shall begin upon the filing of these Articles with the Secretary of State.

The Corporation shall exist perpetually unless dissolved in accordance with the laws of the State of Florida.
