CERTIFICATE OF FIRST AMENDMENT TO AMENDED AND RESTATED ARTICLES OF INCORPORATION OF KINGS RIDGE COMMUNITY ASSOCIATION, INC.

WHEREAS, those certain AMENDED AND RESTATED ARTICLES OF INCORPORATION OF KINGS RIDGE COMMUNITY ASSOCIATION, INC., DATED 12/21/2012 were duly adopted and caused to be recorded on 01/22/2013 at OFFICIAL RECORDS BOOK 4269, PAGE 764, PUBLIC RECORDS OF LAKE COUNTY, FLORIDA (hereinafter "Articles"); and

WHEREAS. Article XI, Section 3 of the Articles provides that the Articles may be amended upon the recordation of an instrument executed by the Community Association upon (i) approval of 66% of the Board and (ii) the Neighborhood Voting Members who are entitled to vote 66% of all votes of the Class "A" Membership in the Community Association and entitled to vote; and

WHEREAS, the amendments attached hereto, incorporated herein by reference, and marked Exhibit "A" ("amendments") were duly adopted by unanimous vote of the Board of Directors at a properly noticed and called meeting of the Board convened on the 14th day of December, 2022; and

WHEREAS, the amendments were presented to a vote of the Neighborhood Voting Members at a duly noticed and called meeting of the Members convened on the 25th day of January, 2023, at which all 45 Neighborhood Voting Members were in attendance; and

WHEREAS, the amendments were adopted by unanimous vote of the Neighborhood Voting Members;

NOW, THEREFORE, be it certified and affirmed by the KINGS RIDGE COMMUNITY ASSOCIATION, INC., that the amendments to the Articles were adopted by the requisite vote of the Neighborhood Voting Members as aforedescribed.

- 1. <u>Recitals.</u> The foregoing whereas clauses form a material part hereof and are hereby incorporated by reference as if fully set forth herein.
- 2. <u>Definitions.</u> All capitalized terms herein shall have the same meaning as those set forth in the Articles unless the context clearly states otherwise.
- 3. <u>Amendments.</u> The amendments to the Articles are set forth in Exhibit "A", attached hereto and incorporated herein by reference.

4. <u>Full Force and Effect.</u> Except as expressly amended herein, all other provisions of the Articles shall remain in full force and effect.
