ARTICLES OF INCORPORATION
OF
FLORIDA FIRE-RESCUE POLITICAL ACTION COMMITTEE, INC.

ARTICLE I - NAME

The name of this Corporation is:

Florida Fire-Rescue Political Action Committee, Inc. (Hereinafter referred to as the "Committee").

ARTICLE II- DURATION

These Articles of Incorporation shall become effective upon the date of their execution and acknowledge, provided the Articles are filed by the Department of State within (5) days or their signing and acknowledgment. If not, these Articles shall become effective upon the date they are filed by the Department of State. The duration of the corporation shall be perpetual.

ARTICLE III - GENERAL PURPOSES

The purposes of the Committee are in general to protect and strengthen the Florida fire and emergency services and in particular to protect and advance the interests of the Committee and the Committee's members by supporting candidates for state office, political committees or political parties, which understand and are sympathetic to these goals.

ARTICLE IV - REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 2710 John Bull Street, Flagler Beach, Florida 32136. The name of the initial Registered Agent of the corporation is Lawrence E. Scovotto.

ARTICLE VI - PRINCIPAL OFFICE

The street address of the principal office of the corporation is 200 East Granada Boulevard, Suite #203, Ormond Beach, Florida 32176.

ARTICLE VII - DIRECTORS

The general management of the affairs of this corporation shall be vested in its board of directors. The board of directors shall consist of three or more individuals, with the exact number fixed in accordance with the bylaws. The names and address of the first directors are as follows:

Each of these directors shall continue as a director of this corporation until the first meeting of the board of directors and until his/her successor is elected, qualified and has accepted. The method of appointment or election of directors shall be as stated in the bylaws.

ARTICLE IX

The directors and officers of this corporation shall not be subject to any extent whatsoever to personal liability for corporate obligations.

ARTICLE X

This corporation shall have no capital stock.

ARTICLE X - PARTICIPATION

All U.S. citizens are eligible to contribute to the Committee and the Committee is authorized to solicit and accept contributions from any person from whom contributions may be lawfully solicited and accepted.

ARTICLE XI - MEMBERSHIP

Candidates for membership shall be subject to the approval by the board of directors and to the payment of dues as set forth in the bylaws.

ARTICLE XII - AMENDMENTS

These Articles may be amended by two-thirds vote of the board of directors.

ARTICLE XIII - DISSOLUTIONS

The duration of the Committee may be dissolved at any time by a majority vote of the board of directors of the Committee. In the event of dissolution, all surplus fund of the Committee shall be promptly distributed to candidates or committees or expended in a manner consistent with applicable state law and for the purposes set forth in these Articles.

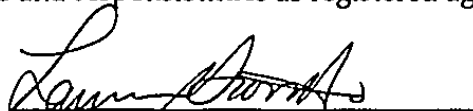
