ARTICLES OF INCORPORATION

OF

CENTRAL PARK SECTION II CONDOMINIUM ASSOCIATION, INC.

ARTICLE III POWERS

[Additions are indicated by underline; deletions by-strike-through]

The Association shall have all of the condominium law and statutory powers of a corporation not for profit and all of the powers and duties set forth in said Condominium Act, the Declaration of Condominium of CENTRAL PARK SECTION II CONDOMINIUM ASSOCIATION, a Condominium, as amended from time to time, and the Bylaws of the Association provided said powers and duties are not inconsistent with the Condominium Act. The Association may enter into lease agreements and may acquire and enter into agreements acquiring leaseholds, memberships and other possessory or use interests for terms up to and including 99 years, whether or not contiguous to the lands of the condominium, intended to provide for the enjoyment, recreation or other use or benefit of the members; including but not limited to lease of recreation areas and facilities. The Association's Board of Directors has the power to enter into, modify, amend, and/or terminate bulk rate contracts for Internet services, communication services, and/or franchised cable television services as a common expense. The Association's Board of Directors has the power to grant, modify, and terminate easements over, across, under, or through the common elements to provide such bulk services to the units and common elements.

ARTICLE XV AMENDMENTS

The corporation reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Incorporation. The Board of Directors or twenty percent (20%) of the total voting interests of the Association may propose an amendment to the Articles of Incorporation. These Articles of Incorporation may be amended at any time by a majority of the voting interests present (in person, by proxy, or other legal means) at any membership meeting at which a quorum is obtained, by a simple majority vote of all voting rights of all members of the corporation and all rights conferred upon the members herein are granted subject to this reservation. Amendments to the Articles of Incorporation shall not be effective until they have been recorded in the official records along with a certificate of amendment and filed with the Secretary of State, Division of Corporations.
