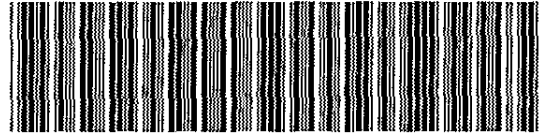



*Pursuant to the provisions of section 617.1002, Florida Statutes, the corporation, previously incorporated as THE GROUP CITY EMERGENCY MEDICAL SERVICE COALITION OF BROWARD COUNTY, FLORIDA, INC., filed on January 17, 1996, and assigned document number N96000000313 adopts the following articles of amendment to its articles of incorporation.*

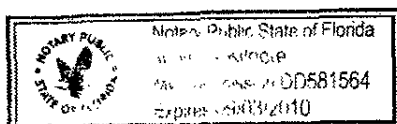
