ARTICLES OF AMENDMENT
OF
THE LAKES AT CHRISTINA OWNERS' ASSOCIATION, INC.

The Articles of Incorporation of THE LAKES AT CHRISTINA OWNERS' ASSOCIATION, INC., shall be amended as follows:

Article IV of the Articles of Incorporation shall be deleted in its entirety and the following shall be added in its place:

"ARTICLE IV - TERM

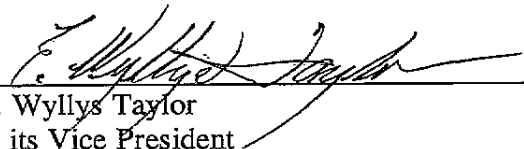
This Association shall be effective on January 11, 1996, and shall have perpetual existence. If, however, this Association is dissolved, the property consisting of the surface water management system shall be conveyed to an appropriate agency of local government, and that if not accepted, the surface water management system shall be dedicated to a similar non-profit corporation."

The foregoing amendment was adopted on October 3, by all of the members and all of the directors of the corporation, which number of votes was sufficient for approval, as evidenced by signature on a Written Consent manifesting their intention that the foregoing amendment to the Articles of Incorporation be adopted.
