ARTICLES OF INCORPORATION
of

WE, THE UNDERSIGNED SUBSCRIBERS, agree to form a non-profit Corporation under the laws of the State of Florida, pursuant to F.S. 617, and hereby make, subscribe, acknowledge and file these Articles of Incorporation as follows:

ARTICLE I
NAME OF CORPORATION

The name of this non-profit corporation shall be:

VICTORY TABERNACLE OF PRAISE MINISTRIES, INC.

ARTICLE II
DURATION OF CORPORATION

This non-profit corporation shall exist perpetually unless dissolved according to Florida law.

ARTICLE III
PURPOSE

This non-profit corporation is organized for the purpose of establishing and maintaining churches, convocation for public worship, missions, schools and other operations and auxiliaries incidental thereto, and to assist members in achieving the common

objective under which this corporation is organized. Nothing in the foregoing shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful purpose which may become necessary or desirable for the furtherance of the corporate objectives expressed hereinabove.

ARTICLE IV MEMBERSHIP

ARTICLE V NONSTOCK BASIS

This non-profit corporation shall be organized on a nonstock basis and shall issue membership certificates to its members, which procedure for issuance shall be established in the bylaws of this non-profit corporation.

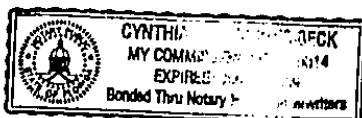

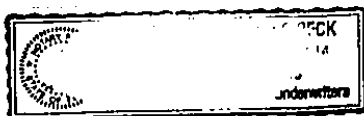
