ARTICLES OF INCORPORATION FOR PATHWAY YOUTH CARE, INC.

The undersigned, acting as Incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I NAME
The name of the corporation shall be Pathway Youth Care, Inc.

The principal place of business and the mailing address of this corporation shall be 6193 Rock Island Road, #215, Tamarac, Florida 33319.

ARTICLE III PURPOSE
Pathway Youth Care, Inc. is a not-for-profit corporation organized for the following purposes:

- 1) To provide residential care for juveniles at risk (ages 10-17) for a period of three to five years.
- 2) To promote an environment in which nurturing care, counseling, educational and career planning can be implemented on a continuing basis.
- 3) To ensure effective and comprehensive psychosocial and psychological assessment, educational tutoring, career planning and outreach, parent counseling and education, judicial advocacy and community outreach.

Pathway Youth Care, Inc. will transact any and all lawful business permitted under provision of chapter 617 of the Florida Statutes or any other Statutes of the State of Florida applying thereto with particular emphasis on the care ofjuveniles at risk.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE IV MANNER OF ELECTION
The manner in which the directors are elected or appointed is as follows:

The initial pool of directors shall total no more than five and no less than three, and shall consist of officers/directors numbering three, and two additional directors. The directors will be appointed in the manner stipulated in the bylaws of the corporation.

ARTICLE V LIMIT OF CORPORATE POWERS
The corporate powers of this corporation are as provided in section 617.0302 of the Florida Statutos.

and operated exclusively for such purposes.
