## ARTICLES OF INCORPORATION OF

The undersigned, for the purpose of forming a non-profit corporation (church) under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

### ARTICLE ONE

#### NAME AND MAILING AND PHYSICAL ADDRESSES

The duration of the corporation is perpetual.

### ARTICLE THREE

#### PURPOSE OR PURPOSES
