**CARIBBEAN AWARENESS FOUNDATION, INC.**  
A Florida Corporation Not for Profit

The undersigned incorporator, hereby adopts the following Articles of Incorporation for the purpose of forming a not for profit corporation pursuant to Chapter 617, Florida Statutes, as amended.

**ARTICLE I - NAME**

The name of the corporation shall be: **CARIBBEAN AWARENESS FOUNDATION, INC.**

**ARTICLE II - PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:  
8250 W. Flagler Street, Suite 120, Miami, Florida 33144.

**ARTICLE III - PURPOSE**

The specific purposes for which the corporation is organized are as follows:

- (1) To educate the public in the history and heritage of Caribbean arts and music so as to preserve their posterity in the diverse South Florida community;

(2) To pursue other charitable and educational purposes related to the foregoing.

#### **ARTICLE IV - POWERS**

The corporation shall have and exercise all rights and powers permissible by law which shall further the specific purposes as are now or may hereafter be conferred except as limited by these Articles of Incorporation or its Bylaws.

#### **ARTICLE V - DISSOLUTION**

Upon dissolution of the Corporation, the Directors of the Corporation shall, after payment of necessary and reasonable expenses, distribute all residual assets of the Corporation to such organization(s) organized and operated exclusively for charitable, educational, religious or scientific purposes which at the time of such disposition, qualify as an exempt organization(s) under Section 501(c)(3) and 170(c)(2) of the Code or to the government of the United States, the state of Florida or any city or county within the state of Florida exclusively for public purposes. Any assets not so distributed shall be distributed for the aforementioned purposes, or to such organization(s) organized and operated exclusively for the aforementioned purposes.

## **ARTICLE VI - INITIAL REGISTERED AGENT, BOARD OF DIRECTORS, AND MEMBERS**

Section 1. The name and street address of the initial registered agent is Paul Perren, 8250 W. Flagler Street, Suite 120, Miami, Florida 33144.

Section 2. The business and affairs of this Corporation shall be managed by a Board of Directors, whose members are referred herein as Directors. The directors will be elected by a majority vote of the members.

The power to adopt, alter, amend or repeal Bylaws for the Corporation shall be vested only in the Directors, as more specifically provided in the Bylaws.

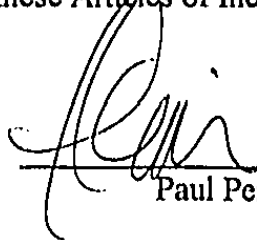
