ARTICLES OF INCORPORATION

OF

CLUB COLLECTIVE EFFORTS, INC.

I, the undersigned acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation and associates together for the purpose of becoming a corporation, not for profit, providing for the formation, liability, rights, privileges and immunities of corporations not for profit.

ARTICLE I

The name of the corporation shall be CLUB COLLECTIVE EFFORTS, INC. The Principal place of business and mailing address of this corporation shall be:

1057 Washington Avenue, Miami Beach, Florida.

ARTICLE II

The existence of this corporation shall be perpetual unless dissolved according to law.

ARTICLE III

The purpose for which this corporation is organized is to create programs for nightclubs, restaurants, bars and lounges to enable owners of such establishments to prevent and prohibit the use and sale of drugs and other illegal activity in their places of business and further to support all persons or organizations which participate in efforts to prevent the disease known as HIV/AIDS.

ARTICLE IV

Members must be alcoholic beverage licensees in the State of Florida. The qualification of members and the manner of their admission to this nonprofit corporation is to be provided for in the Bylaws.

ARTICLE V

This corporation shall be governed by a Board of Directors consisting of a minimum of three (3) directors and a maximum of fifteen (15) directors. The names and addresses of the initial directors and officers are:

ARTICLE VIII

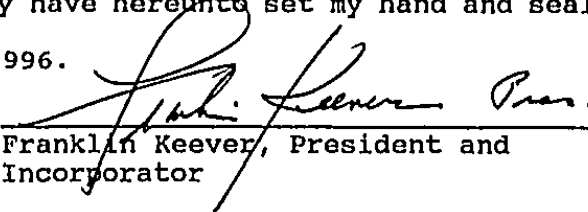

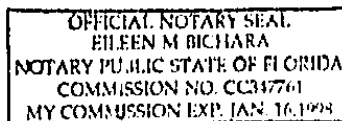

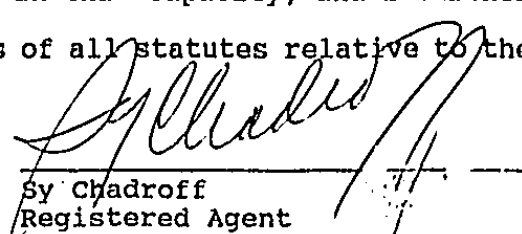
