ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation pursuand to chapter 617, Florida statutes, adopt the following Articles of Transporation:

ARTICLE I - NAME

The name of the corporation shall be: The Alice Foundation, Inc.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS The principal place of business and mailing address of the corporation shall be: 2 South Hwy. 17-92 DeBary, FL 32713.

ARTICLE III - PURPOSES

The specific purposes for which the corporation is organized are:

- To provide a temporary shelter and/or assistance for abused mothers with children who are in the process of fleeing abusive situations.
- В. To engage in any activities permitted under the laws of the United States or the State of Florida that may further the causes herein stated.

ARTICLE IV - ELECTION OF DIRECTORS A. Three initial directors appointed by the incorporators shall serve until new directors are elected and qualified according to the method of election set forth in the bylaws.

ARTICLE V - LIMITATION OF CORPORATE POWERS The corporate powers authorized under section 617.0302, Florida Statutes, shall be exercised by or under the authority of the Board of Directors, and the business and affairs of the corporation shall be managed by the Board of Directors in accordance with these Articles of Incorporation and the bylaws of the corporation. The items set forth in the Articles of Incorporation and the Bylaws shall be fixed, and none shall be adopted, altered, amended, or repealed, without the majority consent of the Board of Directors.

ARTICLE VI - INITIAL REGISTERED AGENT AND STREET ADDRESS The name and street address of the initial registered agent is: Jeannette L. Rowe, 2 South Hwy. 17-92, DeBary, FL. 32713.

ARTICLE VII - THE INCORPORATORS The names and the street addresses of the incorporators are: Jack W. Rowe, Jr., 15 Camelia Drive, DeBary, FL. 32713 Jeannette L. Rowe, 15 Camelia Drive, DeBary, FL. 32713.

ARTICLE VIII - STOCK CERTIFICATES Three (3) stock certificates shall be issued as evidence of ownership. Each certificate shall exhibit the holder's name, the signature of the President and Secretary, and the corporate seal. Stock certificates are not of monetary value; they return no dividends or profits and shall not be sold or exchanged for valuable consideration; however each certificate issued in favor of an individual shall entitle the individual so named on the certificate or their heirs or assigns to take part in the organization, on going control, and/or dissolution of the corporation.
