ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation shall be the National Congress for Fathers & Children--Florida Chapter, Inc.

ARTICLE II

Principal place of business and mailing address

ARTICLE III

Purposes

The specific purposes for which the corporation is organized are:

To eliminate gender-based prejudice and discrimination against males.

To educate the public on the subject of fatherhood in general and the role of divorced fathers in particular.

To enhance and safeguard the interests of children and to protect and improve their relationships with their fathers in advance of, during, and after divorce, while being sensitive to, respective and inclusive of the similar rights and involvement of mothers.

To serve as a networking vehicle for men's, father's, and children's organizations interested in and desirous of advancing an equitable participation of both parents in the parenting of their children, and to serve as a resource for individuals desirous of creating an organization for these purposes.

To cooperate with other organizations and institutions pursuing those purposes mutually common with the National Congress for Fathers & Children (NCFC), Florida Chapter.

ARTICLE IV

Manner of election of directors

The manner in which the directors are elected or appointed shall be in accordance with the bylaws of the corporation.


