ARTICLES OF INCORPORATION
OF
HOLY TEMPLE PENTECOSTAL CHURCH, INC.

ARTICLE I

The name of the corporation shall be:

HOLY TEMPLE PENTECOSTAL CHURCH, INC.

ARTICLE II

The principal place of business and mailing address of this corporation shall be: Route 3 Box 679-D1, Tallahassee, Florida. HOLY TEMPLE PENTECOSTAL CHURCH, INC. shall have to the same extent as if specifically and at length set forth herein all powers conferred upon corporations by Chapter 617, Laws of Florida, 1959.

ARTICLE III

The specific purposes for which the corporation is organized are:

To establish and maintain an independent Pentecostal Church, to support and send forth missionaries that the Church deems worthy of support, and to provide a place of worship for the membership and invite visitors in the City of Tallahassee, County of Leon, and State of Florida.

To establish, maintain and conduct schools, mission churches, mission stations, and to further other religious, educational and charitable work to that end, may adopt and establish by-laws and make all rules and regulations deemed necessary and expedient for the management of its affairs in accordance with law and not inconsistent with these Articles of Incorporation.

To acquire, buy, hold, own, sell, exchange, convey, lease or otherwise dispose of goods, chattels, effects and merchandise.

To mortgage, lease, hypothecate, convey, exchange, and dispose of lands and chattels, to acquire, by gift, annuity, bequest or otherwise, and to promote the diffusion of religious literature and education loyal to the New Testament faith.

ARTICLE IV

The manner in which the directors are elected or appointed is as follows:

This Corporation shall at all times be controlled by the vote of the qualified members of the Holy Temple Pentecostal Church, Inc., as provided in the By-Laws. The Corporate officers charged with the execution of the temporal affairs of the Church shall be known as Trustees. The present Trustees shall manage the temporal affairs as directed by the Church until their successors are elected. The Trustees shall be elected as provided for in the By-Laws.

Persons who believe in repentance toward God, and faith in Jesus Christ as their Savior and Lord, and who are willing to confess Him publicly as Lord and follow Him in Baptism (immersion), and to observe the ordinances of Christ and to be governed by His laws and Church Covenant, are qualified and eligible for membership in this Church Corporation.

The manner of admission to membership shall be by letter of dismission from other churches of like faith and order by satisfactory statement of former membership in a Pentecostal Church and profession of faith as herein before provided upon a favorable majority vote of the membership of said Church corporation present at any meeting of the Church, and in accordance with the By-laws.

ARTICLE V

The Corporation shall have perpetual existence.

ARTICLE VI

This organization shall be governed by a Board of Trustees to consist of not less than three (3) members. The first Board of Trustees of this organization shall consist of:

Mary Ardley

Nancy Almond

This organization may elect deacons and other officers as provided for in the By-Laws.

ARTICLE X

The By-Laws of this Corporation and any changes in the Articles of Incorporation are to be made, altered or rescinded by a two-thirds vote of the qualified members of the Church, present and voting at a regular or special business meeting, after notice as provided in the By-Laws.

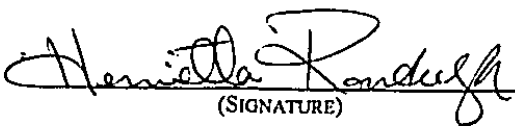
