ARTICLES OF INCORPORATION

OF

PARTIDO CUBANO DE LIBERACION NACIONAL INC.  
(CUBAN PARTY FOR THE NATIONAL LIBERATION)

NON PROFIT CORPORATION

The undersigned subscribers to these Articles of Incorporation, each a natural person, domestic or foreign corporation, partnership or association, competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name under which this corporation will conduct its Business and be known and recognize is:

PARTIDO CUBANO DE LIBERACION NACIONAL INC.  
(CUBAN PARTY FOR THE NATIONAL LIBERATION)

ARTICLE II

PURPOSE

The general nature of the business to be transacted by this Corporation will be:

To promote Liberty, Democracy and Human rights.

To promote Cuba's freedom through all legal means, such as propaganda, literature, lobbying promotion of legislation and Public Relations and personal appearance in lawful meetings.

ARTICLE III

QUALIFICATIONS FOR MEMBERSHIP

The qualification for membership shall be to profess a strong desire to promote a free and democratic Cuba, to be willing through any available legal means and without violation of United States Laws to promote and Lobby for legislation which would cause Cuba to be free and

democratic country; must be over the age of 18 years old.

Admission will be regulated by By-Laws and prospective member must fill out and application and swear to faithfully respect the laws of the United States and the State of Florida.

## ARTICLE IV

### **DURATION**

The duration of this Corporation shall be perpetual unless dissolved according to Florida Law as it now exists or may be from time to time amended by the Florida Legislature.

## ARTICLE V

### **ADDRESS OF CORPORATION**

The Initial address of this Corporation be 10925 S.W. 194TH AVE. Miami, Florida 33196, this address shall be its initial registered office, it's initial registered agent shall be Romulo J. Delgado whose registered address shall be 10925 S.W. 194th AVE., Miami, Florida 33196.

## ARTICLE VI

### **DIRECTORS**

The manner in which Directors are elective would be stated in the by laws. This corporation shall have 5 directors initially. The number of directors may be increased or decreased from time to time in such manner as may be prescribed by the by-laws, but shall never be less than three (10).

The corporation shall indemnify and hold harmless each person who shall serve at any time hereafter as a director or officer of the corporation and any person who serves at the request of this corporation, as a director or officer of any other corporation, from and against any and all claims and liabilities to which such person shall become subject by reason of his having heretofore or hereafter been a director or officer of the corporation or by reason of any action alleged to have been heretofore or hereafter taken or omitted by him as such director or officer, and shall reimburse each such person for all legal and other expenses reasonably incurred by him in connection with any claim or liability provided that no person shall be indemnified against, or be reimbursed for, any expenses incurred in connection with any claim or liability as to which it shall be adjudged that such officer or director is liable for negligence or willful misconduct in the performance of his duties.

The rights accruing to any person under the foregoing provisions shall not exclude any other right to which he may be lawfully entitled nor shall anything herein contained restrict the right of the corporation indemnify reimburse such person in any proper case even though not specifically herein provided for.

No contract or other transaction between this corporation and any other corporation, and no act of this corporation shall in any way be effected or invalidated by the fact that any of the directors of the corporation are pecuniarily or otherwise interested in, or are director individually, or any firm of which any directors or officers of, such other corporation any director may be a member, may be party to, or may pecuniarily or otherwise interested in any contract or transaction of corporation, provided that the fact that he or such firm so interested shall be disclosed or shall have been known to the board of directors or such member thereof

as shall be present at any meeting of the board at which action upon any such contract or

transaction shall be taken; and any director of the corporation who is also a director or officer of such other corporation or is so interested may be counted in determining the existence of a quorum at any meeting of the board of directors of the corporation which shall authorize any such contract or transaction, with the like force and effect as if he were not such director or officer of such other corporation or not so interested.
