OF

ARTICLE 1

The name of the Corporation is: **ALLIANCE FOR THE
PHYSICALLY HANDICAPPED & CHALLENGED, INC.**

ARTICLE 2

The duration of the Corporation is perpetual.

ARTICLE 3

A. This Corporation is a not-for-profit Corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The Corporation is specifically organized as a charitable organization within the meaning and provisions of section 501 (c) (3) of the Internal Revenue Code. The specific purposes of this Corporation is as follows:

1. To develop, operate and fund, through the solicitation of charitable contributions, specific programs which provide

financial and housing assistance, food, clothing, prosthesis and medical equipment repair, psychological and consumer credit referral, computer training for job skills, and other human services, to members of the community who are physically handicapped & challenged as a result of a physical, psychological, or emotional disability or disorder.

B. To exercise all rights and powers conferred by the laws of the State of Florida upon Nonprofit Corporations.

C. Provided, however, that the Corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in the furtherance of its stated purposes.

ARTICLE 4

The Corporation shall have Voting Members, who shall be elected (and may be removed) by the Voting Members, and who shall have all the rights and privileges of members of the Corporation. The Bylaws may provide for Nonvoting Members of one or more classes who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the Bylaws, but who shall not have the right to vote. ARTICLE 5

The Initial Registered Agent is Richard Baker, and the Initial Registered Office is at 13014 N. Dale Mabry Hwy., Suite 179, Tampa, Florida 33618

ARTICLE 6

The initial Board of Directors shall have three (3) Members whose names and addresses are:

The Bylaws shall provide the method of election of all directors, and the number of Directors may be raised or lowered by amendment of the Bylaws but shall in no case be less than three.

ARTICLE 7

The officers of the Corporation shall consist of a president, Vice President, Treasurer, and Secretary. Other Officers may be provided for in the Bylaws. Each Officer shall be elected by the Board of Directors. The name and address of each initial Officer of the Corporation is as follows:
