

# ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a Florida nonprofit corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

## ARTICLE I

### Name

The name of the corporation shall be the Florida Employer Advisory Council, Inc.

## ARTICLE II

### Principal place of business and mailing address

## ARTICLE III

### Purposes

The Florida Employer Advisory Council, Inc. is a nonprofit corporation in which its officers, directors and members perform substantially all of the work for the organization without compensation. It is organized for the following purposes in conformity with 26 U.S.C.A. §501(c)(6):

1. To provide better and more personalized services to Florida employers, and to applicants for unemployment compensation, subsistence allowances, job training and other employment related benefits who use the Florida Department of Labor and Employment Security's Jobs & Benefits Centers. The result will be the improvement of general business conditions due to retraining, placement, and stability in Florida's workplaces.

2. To promote and provide a forum for continual improvements in employer relations; technical services; and communications relating to employment in the state which will assist in developing and enhancing a common business interest for all members and employers.

3. To promote relationships between employers and state Jobs & Benefits Centers' management and staff which will aid in problem-solving, assist applicants, and provide current exchange and dissemination of information and advice.

4. To jointly implement a private and public partnership approach which will inform employers and applicants of FEAC, Inc. and how it works.

5. To develop employer councils which will increase employers' knowledge and utilization of state Jobs & Benefits Centers, leading to improvement of business conditions for employers and developing common business interests..

6. To promote the improvement of business conditions within the state which will reflect the common interests of FEAC, Inc., employers, applicants and state Job & Benefits Centers.

#### ARTICLE IV




