ARTICLES OF INCORPORATION
OF

A FLORIDA NON-PROFIT CORPORATION

Article 1. Name. The name of the Corporation is: Grass Roots of Indian Shores Association, Inc.

Article 2. Duration. The duration of the Corporation is perpetual

Article 3. Purpose. The purpose of the Corporation is as follows:

A. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are; to raise funds for the benefit of the town of Indian Shores and its people, to raise funds to promote political candidates of the town of Indian Shores, and to raise funds to promote referendums for political and cultural purposes for the town of Indian Shores.

B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

Article 4. Members. The Corporation shall have Voting Members. Each voting member shall receive on (1) membership certificate. The name and address of each initial voting members is as follow:

Article 5. Initial Registered Agent and Office. The initial registered agent is John Susor, and the initial registered

office is 19201 Gulf Boulevard, Indian Shores, Florida.

The Bylaws shall provide the method of election of all Directors, and the number of Directors may be raised or lowered by amendment of the bylaws but shall in no case be less than three

Article 7. Officers. The officers of the Corporation shall consist of a President, Secretary and Treasurer. Other officers may be provided for in the Bylaws. Each Officer shall be elected by the Board of Directors (and shall be removed by the Board of Directors) at such time and in such manner as may be prescribed by the Bylaws.
