ARTICLES OF INCORPORATION

GUYANA AMERICAN CULTURAL ASSOCIATION., INC

A NONPROFIT CORPORATION

The undersigned, acting as incorporator, with other persons associated ourselves being desirous of forming a nonprofit corporation, under the provisions of Chapter 617.0202 Florida Statutes, do hereby agree to the following:

ARTICLE 1 NAME

The name of the corporation shall be:

GUYANA AMERICAN CULTURAL ASSOCIATION, INC.

ARTICLE 11 PRINCIPAL PLACE OF BUSINESS & MAILING ADDRESS

The principal place of business and mailing address of this corporation shall be:

ARTICLE 111 DURATION

This corporation shall exist perpetually unless sooner dissolved according to Florida law.

ARTICLES 1V PURPOSES

The purposes for which the corporation is organized are as follows: To encourage and preserves Guyana rich ethnic cultures, to foster and develop in education an awareness of the broad multi cultures of the Guyanese people for all nationalities here in the United States, without limiting the power of the corporation to engaging in any activities or business permitted under the laws of the United States and the State of Florida.
