**ARTICLE ONE - NAME**

**ARTICLE TWO - PRINCIPAL PLACE OF BUSINESS**

THE PRINCIPAL PLACE of business and the mailing address of this corporation shall be 2314 River Park Circle, #2111, Orlando, Florida 32817.

**ARTICLE THREE - PURPOSE**

THE PURPOSES for which the BLIND BODYBUILDER'S ASSOCIATION, INC. is organized are exclusively charitable, and it is the purpose of this corporation to promote physical fitness, bodybuilding, and healthful living for the blind and visually impaired, to assist blind and visually impaired persons

engaging or wishing to engage in the sport of bodybuilding by informing them of the best ways to handle their special needs as blind or visually impaired bodybuilders, and to act as a resource for those providing gym facilities or training services for the blind or visually impaired on how to best meet their blind clients needs. Notwithstanding any other provision of these Articles this organization shall not carry on ANY activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
