

#### GOALS: Our goals are multi-faceted, but not limited to:

- Creating a respectful, positive, and spirited experience for all team members
  at all times, in the Gym and out. This will give them the opportunity to learn,
  to grow, to dream, and to succeed.
- To provide morale boosters for our team, such as Level pins upon moving up, various gifts and surprises, and parties throughout the year.
- Raising funds for the team as a team-not on an individual level. This would include organizing several fund raisers to support the Gym and the Gymnasts. Positive incentives will always be given.
- Make financial contributions to the continuing education of our coaches, not to exceed \$100.00 per coach/per year.
- 5. To participate in community services, such as St. Jude's, Toys for Tots, and the Osceola Children's Home Society.

MEMBERSHIP: The membership will consist of Pre-Tearn and Team parents only. Recreation class parents are invited to all General Membership Meetings and events but will not be allowed to vote and will not be required to pay dues or other fees. Fees are as follows:

SINGLE CHILD ON TEAM: \$20.00
2 OR MORE ON TEAM: \$30.00
PRE-TEAM: \$10.00\*
\*(additional \$10.00 to be paid upon being promoted to team)

YSO fees are due by October 15th. Members who have not paid the membership dues will be considered "Non-Participating Members" and will be subject to suspension.

PARTICIPATION OF "ACTIVE MEMBERS": Defined as a member who is actively involved in one-half of all Booster activities. Every member will receive an "Honor Sheet" (see appendix 1) and will be expected to keep a log of all donations made to YSO-whether it be time spent at meets, on the phone for the YSO, food donations, fund raiser participation, etc.

"Non-Participating Members" will be reviewed by the Executive Board and may be suspended from all Booster activities. Upon suspension, they will be assessed by Price's World of Gymnastics for expenses that the YSO would incur for "active members".

Please be sure to log in on your "Honor Sheet", and to sign in at all YSO activities to maintain an "active status".
