

ARTICLES OF INCORPORATION

OF

PANHANDLE LAND CONSERVANCY, INC. a Plorida not-for-profit conporation



ARTICIJE I - NAME

The name of this Corporation is PANHANDLE LAND CONSERVANCY, INC.

ARTICLE II - ENABLING LAW

This Corporation is organized pursuant to the Corporations Not for Profit Law of the State of Florida, set forth in Part One of Chapter 617, Florida Statutes.

ARTICLE III - PURPOSE

- (a) The primary purpose for which this Corporation is organized is to provide a vehicle for the acquisition, conservation and maintenance of environmentally sensitive lands, historically significant lands and lands which can be utilized in the furtherance of the education of the people of the Florida Panhandle in relation to the inherent value of good stewardship over the natural, historical and cultural resources of the region.
- (b) This Corporation is organized and operated exclusively for carrying out the social, political and educational activities which support the primary purpose listed above, and no part of any net earnings shall inure to the benefit of any member, director, or officer.
- (c) This Corporation shall have and exercise all rights and powers conferred upon corporations under the laws of the State of Florida within the limits of purposes set out in subparagraphs (a) and (b) of this article.

ARTICLE IV - TERM

This Corporation shall have a perpetual existence with its effective date being the 19th day of January, 1996.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial principal office of this Corporation is Suite 106, 1234 Airport Road, Destin, Florida 32541 and the name of the initial registered agent and incorporator of this Corporation at that address is STEVEN K. HALL.

ARTICLE YI - MEMDERSHIP

The authorized number, qualifications, and manner of admission of members of this Corporation, the different classes of membership, if any, the property, voting and other rights and privileges of members, the liability of members for dues or assessments and the method of collection thereof, and the termination and transfer of membership shall be as set forth in the bylaws of this Corporation.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

(a) Board of Directors. The powers of this Corporation shall be exercised and its affairs conducted by a board of not less than throedirectors initially. The number of directors may be changed by a bylaw duly adopted by the members entitled to vote. Directors shall be elected annually by a majority vote of the membership present at the annual meeting. ARTICLE IX - BYLAWS

Bylaws will hereinafter be adopted at the first meeting of the board of directors. Such bylaws may be amended or repeated, in whole or in part by the directors as provided therein.

ARTICLE X - AMENDMENT OF ARTICLES

Amendments to these articles may be proposed by a resolution adopted by the board of directors and presented to a quorum of members for their vote. Amendments may be adopted by a vote of at least two-thirds of a quorum of members of the Corporation.

ARTICLE XI - INDEMNIFICATION

The Corporation shall indemnify any officer or director or any former officer or director, to the full extent permitted by law.

ARTICLE XII - DISSOLUTION

This Corporation shall be dissolved and its affairs wound up by a two-thirds vote of the voting members. In the event of dissolution, the property of the Corporation shall be distributed to a non-profit entity specified by the membership.





RESTATED ARTICLES OF INCORPORATION

OF

PANHANDLE LAND CONSERVANCY, INC. a Florida not-for-profit corporation



ARTICLE I - NAME

The name of this Corporation is PANHANDLE LAND CONSERVANCY, INC.

ARTICLE II - ENABLING LAW

This Corporation is organized pursuant to the Corporations Not for Profit Law of the State of Florida, set forth in Part One of Chapter 617, Florida Statutes.

ARTICLE III - PURPOSE

- (a) The purposes for which the Corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- (b) Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- (c) This Corporation shall have and exercise all rights and powers conferred upon corporations under the laws of the State of Florida within the limits of purposes set out in subparagraphs (a) and (b) of this article.

ARTICLE IV - TERM

This Corporation shall have a perpetual existence with its effective date being the date of filing of these Articles of Incorporation.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE XIII - CERTIFICATION
