ARTICLES OF INCORPORATION

PALM TERRACE COMMUNITY RESIDENT ASSOCIATION, ANGHASSEE, FLORIDA (A CORPORATION NOT FOR PROFIT)

ARTICLE I

The name of this Corporation is Palm Terrace Community Resident Association, Inc.

ARTICLE II

The Corporation is organized pursuant to the provisions of the General Nonprofit Corporation Law of the State of Florida and is a Corporation not for profit.

ARTICLE III (Principal Office)

The principal office for the transaction of business of this Corporation is to be located at 4813 Moncrief Road in Jacksonville, Duval County, Florida. Both the principal office and registered office address are the same.

ARTICLE IV (Duration)

The duration of this Corporation shall be perpetual.

ARTICLE V (Purposes)

The purpose of which this Corporation is formed are exclusively charitable, educational, scientific, social and economic. And will consist of the following:

A The specific and primary purposes are:

MISSION

The mission of the PALM TERRACE COMMUNITY RESIDENT ASSOCIATION shall be to address critical issues affecting family, community and African American Youth. To that end, the purposes of this organization are:

COMMUNITY

- 1. To increase and expand community and economic empowerment through the development of self-sufficiency programs that also include the formation of community development credit unions.
- 2. To reclaim control of communities and to expand opportunities for social, educational, scientific and economic enrichment.
- 3. To design alternative grassroots programs that eliminate the proliferation of drugs, and substance abuse undermining the fabric and structure of the community.

FAMILY

- 1. To develop interventions aimed at establishing stronger, more responsible families.
- 2. To implement programs that foster sound family values and societal responsibilities.
- 3. To educate families regarding roles, responsibilities and acceptable societal values.

YOUTH

- 1. To emphasize the juvenile's awareness of his/her responsibility to society and the law.
- 2. To reduce court case loads by removing some cases from the system, and providing and alternative to incarceration, allowing the state attorney and court to concentrate on more serious cases.
- 3. To allow community involvement in the juvenile justice system.
- 4. To establish multi-cultural family fun centers which will exhibit cultural revelant items and present different core life fundamentals based on current significant themes.
- 5. To house a tutorial program, designed to provide educational assistance and decrease the school drop-out rate by designing a comprehensive after school program.
- 6. To provide video areades with non-violent games which will allow for good positive recreation.
- 7. To provide a gymnasium which will bring organized athletics and physical fitness into an under served community.
- 8. To mobilize appropriate role models who will maximize individual/community involvement and awareness.

- 9. To establish programs to instill self-pride leadership and a sense of strong community responsibility.
- 10. To develop programs to address the prevention of teenage pregnancy and child development skills.
- 11. To establish programs of intervention to address at-risk groups between the ages of 10 and 21 years.
- 12. To establish programs to increase employability skills and conflict resolution skills.
- 13. To implement programs that will change the attitudes and behaviors of the generations of dehumanizing existence of welfare or public assistance recipients.

The programs will provide the foundation for rebuilding the lives of those who are stigmatized and lead them into self-sufficiency, including but not limited to:

Goal-setting

Workshops

Parenting

Peer Support Groups

- (1) To aid, support and assist by gifts, contributions, or otherwise, other corporations, community chests, funds and foundations organized and operated exclusively for charitable, educational or scientific, social and economic purposes, no part of the net earnings of which inures to the benefit of any private shareholder or individual, and no substantial part of the activities of which is for carrying on propaganda, or otherwise attempting to influence legislation.
- (2) To do any and all lawful activities which may be necessary, useful or desirable for the furtherance, accomplishment, fostering, or attaining of the foregoing purposes, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, associations, trusts, institutions, foundations, or governmental bureaus, departments or agencies.
- B. In furtherance, but not in limitation, of the foregoing charitable, educational scientific, social, and economic purposes, the Corporation shell have the following powers:
- (1) To solicit, collect and receive money and other assets and to administer funds and contributions received by grants, gifts, deed, bequest or devise and otherwise to acquire money, securities, property, rights and services of every kind and description, and to hold, invest, expend, contribute, use, sell or otherwise dispose of any money, securities, property, rights or services so acquired for the purpose above mentioned.
- (2) To borrow money, and to make, accept, endorse, execute and issue bonds, debentures, promissory notes, and other corporative obligations for monies borrowed, or in payment for property acquired or for any of the purpose of the Corporation, and to secure payment of any such obligation by mortgage, pledge, deed indenture agreement or other instrument of trust, or by other lien upon, assignment of or agreement in regard to all or any part of the property, rights or privileges of the Corporation.

- (3) To invest and re-invest its funds in such mortgages, bonds, notes, debentures, shares of preferred and common stock, and any other securities of any kind whatsoever, and property, real, personal or mixed, tangible or intangible, all as the Corporation's board of directors shall deem advisable and as may be permitted by law.
- (4) To engage in activities of operating business ventures for the purposes of providing job training, employment services, and managerial development opportunities to said residents for the charitable purpose of furthering the economic development of the community.
 - (5) The operation of said Corporation shall also include the concerns of:
 - A. Continuing care for the elderly
 - B. Historical preservation
 - C. Consumer credit and financial counseling
 - D. Housing
 - E. Economic development
 - F. Public Relations (Newsletter Publication)
 - G. Transportation

All of the foregoing purposes and powers shall be exercised exclusively for charitable and educational purposes in such manner that the Corporation shall qualify as an exempt organization under Section 501 © (3) of the Internal Revenue Code of 1954 as it is currently and shall hereafter be in force and effect.

ARTICLE VI (Restrictions)

- A. No substantial part of the activities of the Corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these activities not permitted to be carried on by a corporation exempt from federal and state income taxes under Section 501 $\mathbb O$ (3) of the Internal Revenue Code of 1954 as the same may be amended from time to time.
- B. The Corporation is formed solely for charitable, educational, economic, social and scientific purposes. The Corporation is not organized, nor shall it be operated for the purpose of generating pecuniary gain or profit, and it will not distribute any gains, profits, or dividends to the Directors, Officers, Members thereof, or to any individual, except that the Corporation shall be authorized and empowered to pay any reasonable compensation for services rendered and to make payment and distribution in furtherance of its specific and primary purposes. The property, assets, profits, and net income of the Corporation are irrevocably dedicated to charitable, educational and scientific purposes, and no part of the profit or net income of the Corporation shall inure to the benefit of any individual.

ARTICLE IX (Winding up and Dissolution)

Upon winding up and dissolution of the Corporation, the assets of the Corporation remaining after payment of, or provision for payment of, all debts and liabilities of the Corporation, shall be distributed to an organization and used exclusively to accomplish the primary purposes for which this Corporation is organized. If the Corporation holds assets in trust, such assets shall be disposed of in such a manner as directed by decree of the Circuit Court of the County in which the Corporation's principal office is located, upon petition by the Attorney General, or by any persons concerned in the liquidation in a proceeding to which the Attorney General is a party. No member, director or private individual shall be entitled to share in the distribution of any of the assets upon such dissolution.

The legal affairs of the Corporation shall be managed by the officers who shall be elected at the annual meeting each year to serve the ensuing year. The officers of the corporation shall serve until their respective successors in office shall be elected and duly qualified.

ARTICLE X

[Revenue]: No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II hereof. The Corporation shall not in any way, directly or indirectly, carry on propaganda or otherwise attempt to influence legislation, or participate or intervene in any political campaign on behalf of any candidate for public office, by publishing or distributing statements or otherwise. Notwithstanding any other provisions of these Articles, the Corporation shall not carry on other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501(C) (3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law), or (b) by a corporation, contributions to which are deductible under Section 170 (2) of the Internal Revenue Code of 1954 (or the corresponding provision of any further United States Revenue Law).


