

### ADOPTED AMENDMENT TO THE ARTICLES OF INCORPORATION OF HIDDEN PINES AT COUNTRYSIDE HOMEOWNERS ASSOCIATION, INC.

The following is an adopted amendment to the Articles of Incorporation of Hidden Pines at Countryside Homeowners Association, Inc., originally recorded at Official Records Book 9260, Page 1431, Public Records of Pinellas County, Florida.

Item No. 1: Article VII, Section 1 of the Articles of Incorporation is hereby amended to read as follows:

#### ARTICLE VII

#### **BOARD OF DIRECTORS**

Section 1. The Association's affairs are to be managed by a Board of Directors composed of either three or five directors, as determined by the membership from time to time. The term of office for all directors is one year. Any vacancies occurring between annual meetings will be filled by appointment by the remaining directors. Directors must be members of the Association. Elections will be conducted by ballot, in accordance with procedures adopted by the Association from time to time. Cumulative voting is not permitted.

END OF ADOPTED AMENDMENT
