ARTICLES OF INCORPORATION

The undersigned, acting as incorporator, desiring to form a corporation for profit pursuant to the Florida General Corporation Act, adopt(s) the following Articles of Incorporation for such corporation.

ARTICLE I

Name

The name of the Corporation shall be LAKEFRONT PROPERTY OWNERS ASSOCIATION, INC.

ARTICLE II

Principal Office

The principal office of the Corporation is located at Maitland, Florida, and its mailing address is 1110 North Lake Sybelia Drive, Maitland, Florida 32751.

ARTICLE III

Corporate Purposes. Power and Rights

The purpose of the Corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV

Duration of the Corporation

Existence of the Corporation shall commence on the date all fees are paid and these Articles of Incorporation are filed by the Secretary of State and the Corporation shall exist perpetually unless dissolved according to law.

ARTICLE V

Authorized Stock

The total number of shares of capital stock which the Corporation has the authority to issue is 1,000 shares of Common Stock, with a \$1.00 par value per share.
