

### STATEMENT OF PURPOSE

Bay Area Baseball is an organization dedicated to helping high school age young people. In our society today teenagers are overwhelmed with an alarming number of negative influences including drug and alcohol abuse, gangs, negative peer pressure, poor academic performance, and the lack of motivation to both set and achieve quality, worthwhile goals. It is the highest priority of this organization to offer our young people positive principles which will not only benefit them in their athletic pursuits, but also in their academic and personal lives.

Our athletes commit to an intensive three month summer schedule (June-August) in which they will travel to six different states to compete in tournaments and spend approximately 35 nights in hotels. In addition they will undergo a demanding daily practice schedule in which they will be instructed and worked with by qualified coaches, on a team and an individual basis. Our staff of three full time coaches and four part time coaches all have played on the collegiate and/or professional level and have experience coaching on the youth level. The physically and mentally demanding effort and performance we ask from our young people is a necessity as they endeavor to become the tupe of player with the physical skills and mental toughness necessary to compete at the college or professional level.

The motto we have adopted for Bay Area Baseball is "Committed to Earning College Scholarships for Youth." Our young people make this their priority and we as coaches do everything in our power to make a college scholarship a reality. Our statement of purpose lists three endeavors: 1) Offer maximum improvement of each of our player's baseball fundamentals and skills in an effort to prepare them for college baseball. 2) Build character in our young people which will not only benefit them in their athletic pursuits but also in every other area of their lives. 3) Emphasize the principles of education, discipline, hard work, and a drug-free life, as the surest means to success in baseball and in life. A successful athlete is not nearly as rewarding to us as a successful person. This is what Bay Area Baseball has dedicated itself to accomplish in the lives of our young people and in our community.


