ARTICLE ONE
ORGANIZATION

- (1) The name of this organization shall be Jehovah Jireh Christian Ministries, Inc.
- (2) The organization may at its pleasure by a vote of the membership body change its name.

ARTICLE TWO
PURPOSE

The principal office of Jehovah Jireh Christian Ministries, Inc. shall be:

ARTICLE THREE
PURPOSE

The following are the purposes for which this organization has been organized:

1. To spread the Gospel of Jesus Christ through:
 - A. Preaching the full Gospel.
 - B. Music, both in live and recorded performances. This is to include but not be limited to the creation, possession, maintenance and operation of at least one (1) mobile sound truck that will be able to go anywhere and provide a sound system for the purpose of ministering the Gospel. Jehovah Jireh Christian Ministries, Inc. may also possess and maintain support vehicles as necessary to facilitate the mobile sound systems. Jehovah Jireh Christian Ministries, Inc. will also maintain multiple sound (PA) systems of various types to facilitate public ministry.
 - C. Creation and distribution of Christian media, both electronically and mechanically.
2. The chartering and ordination of other Christian ministries through:
 - A. Organizing workshops for the purpose of helping and advising existing or prospective music ministries.
 - B. Providing general advice, conducting lessons and master classes.
3. Conducting Christian retreats for youth, adults, music ministers, and others.
3. Displaying the power and strength of God.
4. The spiritual edification of children, but with an emphasis on the underprivileged and those in the inner-cities. This will be accomplished by, but not limited to:
 - A. Leading them to Jesus Christ.
 - B. Nurturing their talents.
 - C. Bolstering their self-esteem.
 - D. Creating opportunities for them to learn and experience new things.

12. Providing for them Christian role models to guide and teach them.
13. The establishment and administration of a scholarship program.
5. Producing an annual recording of music of the charter members of Jehovah Jireh Christian Ministries, Inc..
6. To maintain a fund or funds and real and personal property to distribute any income or interest generated therefrom, exclusively of charitable, religious, or education purpose.






