ARTICLES OF INCORPORATION for

TEACHERS INCENTIVE PROGRAMS, INC. A FLORIDA NONPROFIT CORPORATION

Pursuant to the provision of the Florida Not For Profit Corporation Act, Chapter 617, Florida Statutes, the undersigned incorporators hereby adopt the following Articles of Incorporation:

ARTICLE I Name

The name of the Corporation is: Teachers Incentive Programs, Inc.

ARTICLE II

Principle place of business and mailing address

ARTICLE III Purpose

The purpose of the Corporation is as follows:

- A. This Corporation is a Not-For-Profit Corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this Corporation are to provide charitable contributions to teachers and educators, to contribute funds to schools, to provide educational materials to educators through a newsletter, and to educate the public to the contributions educators make in the development of our country's future by sponsoring community events. This corporation is organized exclusively for one or more of the purposes as specified in Section 501 (c) (3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.
- C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its

stated purposes.

ARTICLE IV Manner of election of Directors

The Bylaws shall provide the method of election of all Directors, and the number of Directors may be raised or lowered by amendment of the Bylaws but shall in no case be less than three (3).

The initial Board of Directors shall have 5 members whose names and addresses are:

ARTICLE V Limitations of Corporate Powers

The corporate powers of this Corporation are as provided in Section 617.0302, Florida Statutes, except that no substantial part of the activities of this Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation [except as otherwise provided by Section 501 (h) of the Internal Revenue Code], and this Corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of these Articles, this Corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code or (2) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.

The Corporation is organized (and shall be operated) on a non stock basis within the meaning of the Florida Not For Profit Corporation Act, and shall not have the power to issue shares of any type cr class of stock, but may issue membership certificates if so provided in the Bylaws.

ARTICLE XI

Upon the dissolution of this Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this Corporation shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose.

ARTICLE XII Duration

The duration of the Corporation is perpetual.
