# ARTICLES OF INCORPORATION

# POVERBLEO AUXILIARY, INC. (A Corporation Not for Profit)

The undersigned hereby submit the following Articles of Incorporation for the formation of a corporation not-for-profit in accordance with the laws of the State of Florida.

# I NAME

The name of the corporation shall be POVERELLO AUXILIARY, INC. (the "Corporation").

# II ADDRESS

The address of the principal office of the Corporation and the mailing address of the Corporation shall be 2292 Wilton Drive, Wilton Manors, Florida 33305, but the Corporation may maintain offices and transact business in other places within or without the State of Florida as may from time to time be designated by the Board of Directors. Furthermore, the Board of Directors may from time to time relocate the principal office of the Corporation.

## III PURPOSE

This Corporation is organized for the purpose of raising funds for, and generating charitable contributions to, Poverello Center, Inc. and in aiding in the operation of and in the fulfillment of the purposes for which Poverello Center, Inc. has been established and in aiding other similar charitable organizations qualified under Section 501(c)(3) of the Internal Revenue Service Code and dedicated to the purpose of assisting persons suffering from the disease known as AIDS and other charitable endeavors related to the assistance of those suffering from the disease known as AIDS. An organization is a qualified organization for the purpose of these Articles only if it is described in Section 501(c)(3) and Section 509(a)(1) or 509 (a)(2) of the Internal Revenue Code of 1986 as amended, or corresponding sections of any future federal tax code.

# IV DIRECTORS

The governing body of this Corporation shall be the Board of Directors. The Board of Directors of Poverello Auxiliary, Inc. shall be elected or appointed in accordance with the provisions of the Bylaws of Poverello Auxiliary Inc.

# REGISTERED AGENT

The registered office of Poverello Auxiliary, Inc. shall be located at 550 S.W. 12 Avenue, Deerfield Beach, Florida 33442. The name and address of the initial registered agent of Poverello Auxiliary, Inc. is David T. Price, Esq., 550 S.W. 12 Avenue, Deerfield Beach, FL 33442.

# VIII OFFICERS

The affairs of this Corporation shall be managed on a day-to-day basis by the officers in accordance with the Bylaws. The officers shall be appointed from time to time by the Board of Directors. Officers shall serve at the pleasure of the Board of Directors.

# IX DISSOLUTION

In the event of dissolution of Poverello Auxiliary, Inc., the residual assets of the Corporation will be distributed to The Poverello Center, Inc., or to one or more other qualified organizations provided they are at the time exempt organizations described in Sections 501(c)(3) and 170(c)(2) and 509(a)(1) or 509(a)(2) of the Internal Revenue Code of 1986 as amended or corresponding sections of the Internal Revenue Service Code.

#### X DURATION

The Corporation shall have perpetual existence.

# XI BYLNWS

The first Bylaws shall be adopted by the directors and may be altered, amended or rescinded by the directors in the manner provided by the Bylaws.

# XII AMENDMENTS

These Articles may be amended or repealed, in whole or in part, by a majority vote at any duly organized meeting of the directors.

# XIII CHARITABLE RESTRICTIONS AND LIMITATIONS

- 1. No part of the net earnings of Poverello Auxiliary, Inc. shall enure to the benefit of or be distributed to its governing Board of Directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered, and to make payment and distribution in furtherance of the purposes set forth in Article III hereof.
- 2. The Corporation shall not attempt to influence legislation as a substantial part of its activities, nor shall it participate to any extent in any political campaign for or against any candidate for public office.
- 3. It may be intended that this Corporation shall have the status of a Corporation which is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code, as an organization described in Section 501(c)(3) of the Code, and described in Section 509(a)(3) of the Code. These Articles shall be construed accordingly, and all powers and activities of the Corporation shall be limited accordingly.

4. At no time shall the Board of Directors of the Corporation be constituted so as to be controlled directly or indirectly by one or more disqualified persons with respect to the Corporation (as defined in Section 4946 of the Code) other than "foundation managers" as defined by the Code.
