

First: Article I of the Articles of Incorporation for 211 Tampa Bay Cares, Inc. is hereby amended to read as follows:

The name of this corporation shall be 211 Tampa Bay Cares, Inc. The principal place of business for this corporation shall be 13921 Icot Blvd., Suite 700, Clearwater, FL 33760.

Second: Article III of the Articles of Incorporation for 211 Tampa Bay Cares, Inc., is to be removed.

Third: Article VI of the Articles of Incorporation for 211 Tampa Bay Cares, Inc., is to be removed.

The By-Laws of the corporation may be amended, altered, or rescinded by a two-thirds (¾) vote of the Directors present at any regular meeting.
