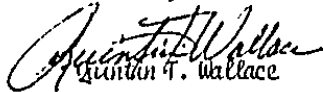

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 017, Florida Statutes, adopt(s) the following Articles of Incorporation:

Purpose(s)

The specific purpose(s) for which the corporation is organized is(are):

The purpose of the organization called Daytona Deliverance Church of God Inc. is organized are exclusively religious, charitable, literary and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue Law.

The purpose also shall be to cultivate, promote, promulgate and extend the teachings and precepts of Jesus Christ. In addition, to maintain a Biblical Christian Church, providing a place to worship, establishing other churches in other cities, states and international locations. Further, it shall be our purpose to establish, maintain and conduct schools for the religious instruction of the young. We will also perform other charitable works as: drug rehabilitation counseling, feeding the needy, programs for the elderly, and destitute and distressed men women and children. Our purposes are available to all races, creeds, and sexes.

ARTICLE IV **Manner of election of directors**

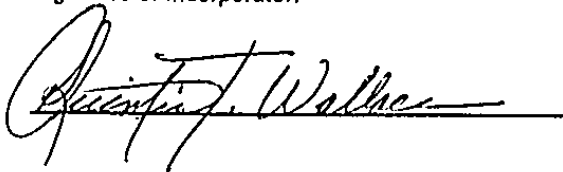

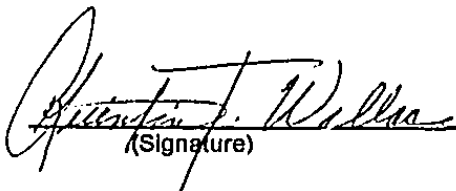

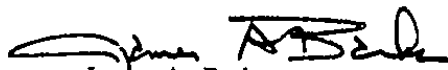

ARTICLES OF AMENDMENT TO THE ARTICLES
OF INCORPORATION

OF

DAYTONA DELIVERANCE CHURCH OF GOD, INC.

Pursuant to the provisions of Section 617.1006 of the Florida General Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is DAYTONA DELIVERANCE CHURCH OF GOD, INC.

2. The following amendment of the Articles of Incorporation was adopted by the members and directors of the corporation on January 15, 1997, in the manner prescribed by the Florida General Corporation Act:

The Articles of Incorporation are hereby amended by adding the following items:

"ARTICLE IX

Further purposes and objectives of the corporation shall be:

Providing a place of worship for its members, who shall be members in good standing of the Church of God, Cleveland, Tennessee, and conducting the affairs of the congregation according to the rules and regulations of the Church of God, Cleveland, Tennessee, and specifically the General Assembly Minutes of the Church of God, Cleveland, Tennessee; promoting the cause of Christianity in accord with the teachings, tenets, and customs of the Church of God, Cleveland, Tennessee; receiving, managing, and disbursing gifts, bequests, and other funds for the benefit of the congregation and the Church of God, Cleveland, Tennessee; owning and maintaining suitable buildings and facilities necessary for their acquisition, upkeep,

maintenance and sale, all in accord with the General Assembly Minutes of the Church of God, Cleveland, Tennessee.

ARTICLE X

In the event this corporation shall cease to exist, or depart from the polity of the Church of God, Cleveland, Tennessee, as expressed in the General Assembly Minutes of the Church of God, Cleveland, Tennessee, and otherwise, the assets of the corporation shall revert to the State Trustees for the Church of God in the State of Florida, or to one or more organizations described in Section 501 (C) (3) of the Internal Revenue Code or the corresponding sections of any prior or future Internal Revenue Code. Further, that the proceeds/assets from the disposition must go directly into real property purchases or improvements."

3. The amendment was adopted by the members and the number of votes cast for the amendment was sufficient for approval.
