A Corporation Not for Profit

We, the undersigned, with other persons, being desirous of forming a Corporation Not for Profit, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLEA

Name

The name of this corporation is WOMEN'S CHAMBER OF COMMERCE OF BROWARD COUNTY, INC.

ARTICLE II

Purposes

The general nature and purpose of this corporation for which it is formed are as follows:

- 1. Development and education of women business and community leaders

ARTICLE III

Term of existence

This corporation is to exist perpetually.

Officers

The initial Officers of this corporation shall be a President and Chairman and such other officers and committees as the Constitution and By-Laws of this corporation may prescribe or as this corporation may elect in accordance with its needs. Annual Meeting

The annual meeting of this corporation shall be held in the month of November of each year and such other meetings may be held as are provided in the Constitution and the By-Laws.
