Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, de hereby certify:

FIRST: The name of the Corporation shall be Ke Aloha Respite House Corporation.

SECOND: The place in this state where the principal office and the registered office address of the Corporation is to be located at 3320 Sheaf Road, City of Apopka, Orange County, Florida, 32703. The principal address and the registered office address are the same.
