Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

FIRST: The name of the Corporation shall be Ke Aloha Respite House Corporation.

SECOND: The place in this state where the principal office and the registered office address of the Corporation is to be located at 3320 Sheaf Road, City of Apopka, Orange County, Florida, 32703. The principal address and the registered office address are the same.

THIRD: Said corporation is organized exclusively for charitable, educational, religious and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

FIFTH: No part of the net earnings of the corporation shall be distributable to or inure to the benefit of its members, officers, other private persons or trustees, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make distributions and payments in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be otherwise attempting to influence legislation or the carrying on of propaganda, and the corporation shall not intervene in, or participate in (including the distribution or publishing of statements) any political campaign in opposition to or on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

SIXTH: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to a local or state government, or the federal government, for a public purpose.

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

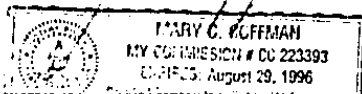
