The undersigned acting as incorporator of a corporation pursuant to Chapter 617 of the laws of the State of Florida, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be:

ARTICLE II. PURPOSE

The purpose of this corporation is to provide printing services to non profit organizations and to governmental agencies.
