ARTICLE I

THE NAME OF THE CORPORATION IS TALQUIN RIDING FOR THERAPY, INC., THE ACRONYM BEING TROT.

ARTICLE II

THE LOCATION OF THIS CORPORATION SHALL BE IN LEON AND GADSDEN COUNTIES, FLORIDA AND THE PRINCIPAL OFFICE ADDRESS SHALL BE ROUTE 1, BOX 3159, HAVANA, FL 32333.

ARTICLE III

THE GENERAL NATURE OF THE OBJECTIVES AND PURPOSES OF THIS CORPORATION SHALL BE:

- A. THE CORPORATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE, ELEEMOSYNARY, EDUCATIONAL, SCIENTIFIC AND PROFESSIONAL PURPOSES, WHOSE GOAL AS A NON-PROFIT ORGANIZATION UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE SERVICE CODE IS TO PROMOTE THE AWARENESS, ADVANCEMENT AND USE OF HIPPO THERAPY FOR PERSONS WITH DISABILITIES.
- B. TO ENGAGE IN ANY KIND OF ACTIVITY AND TO ENTER INTO, PERFORM AND CARRY OUT CONTRACTS OF ANY KIND NECESSARY OR IN CONNECTION WITH OR INCIDENTAL TO THE ACCOMPLISHMENT OF ANY ONE OR MORE OF THE NON-PROFIT PURPOSES OF THE CORPORATION.
- C. THIS CORPORATION SHALL NOT BE ORGANIZED FOR THE PECUNIARY OR BUSINESS PROFIT OF ITS MEMBERS, DIRECTORS, OFFICERS OR ANY OTHER INDIVIDUALS CONNECTED WITH THIS CORPORATION.
- D. TO ACQUIRE BY GIFT OR PURCHASE, HOLD, SELL, CONVEY, ASSIGN, MORTGAGE OR LEASE ANY PROPERTY, REAL OR PERSONAL, FOR SAID CHARITABLE PURPOSE AS THE BOARD OF DIRECTORS IN THEIR DISCRETION MAY DETERMINE.
- E. TO BORROW MONEY AND TO ISSUE EVIDENCE IN THE FURTHERANCE OF ANY OR ALL OF THE OBJECTS OF ITS BUSINESS, AND TO SECURE LOANS BY MORTGAGE, PLEDGE, DEED OF TRUST OR OTHER LIEN.

THE MANNER IN WHICH THE DIRECTORS ARE TO BE ELECTED/APPOINTED ARE STATED WITHIN THE BYLAWS OF TROT, INC.

The Board of Directors met and made the following Amendments to the Articles of Incorporation on July 8, 1996:

Add the following to Article III the following:

F. NOTWITHSTANDING ANY OTHER PROVISIONS OF THESE ARTICLES, THE ORGANIZATION IS ORGANIZED EXCLUSIVELY FOR ONE OR MORE OF THE PURPOSES AS SPECIFIED IN SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE OF 1954, AND SHALL NOT CARRY ON ANY ACTIVITIES NOT PERMITTED TO BE CARRIED ON BY AN ORGANIZATION EXEMPT FROM FEDERAL INCOME TAX UNDER IRC 501(C)(3) OR CORRESPONDING PROVISIONS OF ANY SUBSEQUENT FEDERAL TAX LAWS.

G. NO SUBSTANTIAL PART OF THE ACTIVITIES OF THE ORGANIZATION SHALL BE CARRYING ON PROPAGANDA, OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION (EXCEPT AS OTHERWISE PROVIDED BY IRS 501(H) AND DOES NOT PARTICIPATE IN, OR INTERVENE IN (INCLUDING THE PUBLICATION OR DISTRIBUTION OF STATEMENTS), ANY POLITICAL CAMPAIGN ON BEHALF OF, OR IN OPPOSITION TO, ANY CANDIDATES FOR PUBLIC OFFICE.

Add the following to Article VII:

NO PART OF THE NET EARNINGS OF THE ORGANIZATION SHALL INURE TO THE BENEFIT OF ANY MEMBER, TRUSTEE, DIRECTOR, OFFICER OF THE ORGANIZATION, OR ANY PRIVATE INDIVIDUAL (EXCEPT THAT REASONABLE COMPENSATION MAY BE PAID FOR SERVICES RENDERED TO OR FOR THE ORGANIZATION), AND NO MEMBER, TRUSTEE, OFFICER OF THE ORGANIZATION OR ANY PRIVATE INDIVIDUAL SHALL BE ENTITLED TO SHARE IN THE DISTRIBUTION OF ANY OF THE ORGANIZATION'S ASSETS ON DISSOLUTION OF THE ORGANIZATION.
